Portuguese Presidency of the EU – Health Priorities

The Portuguese Presidency of the EU started on the 1st July for a period of six months till 31 December 2007.

In the field of health, the programme of the Portuguese Presidency, along the lines of the 18-month Programme of the German, Portuguese and Slovenian Presidencies, will focus mainly on health promotion, disease prevention, access to healthcare and innovation. The Portuguese Presidency will also strive to ensure continuity and sustainability of policies, through the development of initiatives on themes elected as priority by previous presidencies, such as health and health systems impact assessment (following the Finnish Presidency initiative on Health in All Policies), HIV/aids and Pharmaceutical Innovation (following the work of the German Presidency on these two fields).

In the present demographic context, characterized by low birth rate, population ageing and intense migratory flows from third countries to some member states, health services are faced with new and important challenges.

Thus, the main initiative of the Portuguese Presidency in the field of health, the Conference «Health and Migration in the

EU – better health for all in an inclusive society», to be held in Lisbon on 27th and 28th September, will aim at mobilizing member states, national and international organizations and NGOs to discuss and work on proposals of intervention strategies and policies, in order to and cultural activities aimed at facilitating inclusion; and to contribute to the definition of health policies and strategies aimed at improving migrants' integration, which could be implemented at both EU and Member States levels.

With the goal of contributing to the definition of the European Health Strategy, following the debate launched by the European

Commission on this issue, a Round Table on Health Strategies in Europe will be held, on 12-13 July, which will aim to define a framework of reference for the development of an European health strategy, as well as to discuss strategies to fight specific diseases

and genderspecific issues and other socioeconomic

p r o m o t e health, prevent disease and improve the access to healthcare by migrants.

Specifically, the Conference's objectives are: to assess the 21st century international migration moves and their impact on the EU demography and economy; to improve knowledge on migrants' health status and health determinants (accounting for the demographic dynamics of the migratory process and its impact; the specific political and legal frameworks at both national and international levels; the socio-economic integration of migrant families); to identify best practices about migrants' access to health services (health promotion, prevention and access to care), encompassing formal and informal care, as well as social determinants, in order to improve equity and reduce health inequalities.

Further to these initiatives, from which the Presidency expects to take conclusions to the Council in cooperation with member states MS, the Presidency will give political impetus to the legislative and nonlegislative work of the community institutions. Among other issues, this includes the extremely important debate on the Community framework on safe, highquality and efficient health services and the European Health Strategy.

The Portuguese Presidency will pay special attention to the future developments at

the international level, particularly in what concerns the World Health Organization, coordinating community positions in the field of tobacco control (at the 2nd Conference of the Parties of the WHO Framework Convention on Tobacco Control), at the WHO-Europe Regional Committee, at the 2nd Meeting of WHO's Intergovernmental Working Group on

Public Health, Innovation and Intellectual Property, at the meeting of WHO's Intergovernmental Working Group on sharing of influenza virus samples and on the implementation of the International Health Regulations.

The World Health Organization Director General, Dr Margaret Chan, visited the European Commission on 12 June and met its President, Mr. Barroso, and the Commissioner for Health and Consumer Protection, Markos Kyprianou, to discuss about the health consequences of climate change, and the global health security. This was a good opportunity for the European Commission and WHO to discuss on strategic health priorities, and the actions to be taken in partnership to improve health at EU and global level.

Quality Assurance Processes in Physiotherapy Education

In order to assist Member Organisations in developing, promoting and maintaining high quality physiotherapy education the Education Working Group of the ER-WCPT is undertaking to collect information on the processes used to quality assure both the courses and their delivery. Whilst all providers of education will be striving to provide a high quality education experience, it is of importance that good practices are shared, not least as the Bologna process has a greater impact on education levels and delivery across Europe.

In the Bologna Declaration (1999) the European Ministers of Education committed themselves to establish the

European Higher Education Area by 2010. This Declaration encourages co-operation in quality assurance of higher education across Europe with a view to developing comparable criteria and methodologies. Other important goals agreed in Bologna are easily comparable degrees, a system based on two main degree cycles (subsequently a third cycle has been included), a common European system of credits and mobility of students and teachers.

In 2001 the European Ministers of Education meeting in Prague invited the European Network for Quality Assurance in Higher Education (ENQA) to collaborate in establishing a common framework of reference for quality assurance, which would directly work towards the establishment of the European quality assurance framework by 2010. Two years later, in Berlin, the Ministers recommended ENQA to contribute even more directly to the European quality assurance process. In the Berlin Communiqué ENQA received a double mandate from the Ministers to explore ways of ensuring an adequate peer review system for national quality assurance agencies and to develop an agreed set of standards, procedures and guidelines on quality assurance.

In the Bergen meeting of May 2005 the European Ministers of Education adopted the "Standards and Guidelines for Quality Assurance in the European Higher Education Area" drafted by ENQA (http://www.enqa.eu/files/). The Ministers committed themselves to introducing the proposed model for peer review of quality assurance agencies on a national basis. They also welcomed the principle of a European register of quality assurance agencies based on national review and asked that the practicalities of its implementation would be further developed by ENQA.

The Education WG would be keen for MOs to share examples of how physiotherapy education is quality assured in their own country. In particular we would welcome feedback on whether the ENQA guidelines have been or are being adopted/applied within their country.

It would be helpful to hear what processes are being applied

- By independent Quality Assurance bodies, in particular how frequently: for example in England an independent QA body, the Quality Assurance Agency carries out external reviews every 5years
- By the MOs themselves: for example the MO may undertake some monitoring of the programme content and its delivery
- And by the education institutes; many HEIs have internal Quality Assurance monitoring systems such as student evaluation of teaching, and use of external examiners

It is hoped that the Education Working Group receive more examples of quality assurance practice to share with colleagues. The use of such examples will help inform a guidance document to be produced for use by the MOs in meeting the future requirements of the Bologna process.

Bologna Summit Outcomes

The Higher Education Ministers from the 45 European countries participating in the Bologna Process, met in London on 17-18 May 2007, to review the progresses made since the Bergen meeting in 2005. The result is that there have been good progresses in relation to: 3 cycle degree system (Bachelor, Master and Doctorate); quality assurance; recognition of degrees and study periods; and, strengthening links between higher education and research sectors. However, some students unions believe that the European governments are only implementing the higher education reforms that fit their national agenda, and are urging the Member States to implement the commitments of the Bologna process, to create a European Area of Higher Education by 2010.

European Commission consultation on Health Strategy

The European Commission published on 1 June 2007 a report on the results of the consultation to the EU Health Strategy, which received more than 150 contributions.

In its summary of the consultation, the European Commission acknowledges many of the contributions made by the health community. The general points made by the contributors to this consultation are listed below:

- Support to the cross-border nature of health. An approach which emphasizes the idea of "health in all policies" and supports the EU engagement in global issues. Several contributors also mentioned the need to coordinate with other international organisations such as the World Health Organisation.
- Definition of the objectives of the Strategy in the short and long term. Setting objectives was considered to be of major importance for the health strategy.
- Involving stakeholders in the drafting

of the health strategy and in other policy initiatives in the health field.

- Called for enhanced coordination at the EU and national level. Member States have to link their actions to the actions at EU level but they also have to develop a sense of ownership of the strategy.
- Use of the Open Method of Coordination to achieve the objectives set out by the EU Health Strategy. Some contributors also suggested a European level structure to oversee the implementation of the strategy.
- Stressed the need to improve health information to support the health strategy and called for the development of common data.

Taking these positions into account, the Commission will adopt the new health strategy later this year.

European Commission is asked to take action on health services

The European Parliament adopted, on 23 May 2007, the report on 'The consequences of excluding health services from the Directive on Services in the Internal Market', from which the controversial amendment 172 of Toine Manders (ALDE) asking to reintroduce health services into the Services Directive (to which ER-WCPT and other Healthcare organisations reacted) was excluded. The call for a separate Directive on Health Services was also rejected and the

European Commission is asked to propose appropriate tools to codify the European Court of Justice case law on EU citizens' right to seek healthcare in other Member States, with costs covered by their own health system. For further information:
