Education Matters WG Report 2006 European Region of the WCPT

Introduction:

The main objectives of the Education Matters Working Group are to promote the quality of physiotherapy education in Europe and to contribute to facilitate the reciprocity of recognition of physiotherapy qualifications.

The activity of the year 2006 can be divided in two periods, in reference to the General Meeting (GM), held in Croatia, in May 2006.

At the GM we have had the opportunity to present the results of the work developed from 2004 to 2006, and it was rewarding to see that all the recommendations proposed to the GM were approved. In this report we will only summarise the main results of the GM, and highlight the mandate received for a new cycle of activity.

Terms of reference for the period 2006-2008

The terms of reference of the working group for the period of 2006 – 2008 were agreed at the General Meeting 2006 as follows:

Further, develop an executive summary of the Benchmark Statement and with specific references to the original document. Continue to monitor the implementation of the European Physiotherapy Benchmark Statement Updating of the Policy Statement on Physiotherapy Education since Education is evolving due to the Bologna Process;
- Continuation of the Project on Specialisation;
- Address education issues for Member Organisations involved in the enlargement process and cooperate with the EU Working Group;

- Monitoring and reacting to issues as they arise from enlargement;
- Identify information to be included on the website under the button of education relating to basic education, post basic education, and research;
- Gather information on Quality Assurance measures in Physiotherapy Education;
- Gather information on Continuous Professional Development activities within the Member Organisations in collaboration with the Professional Issues Working Group Monitor the developments in re-registration, recertification in all the ER-WCPT countries in collaboration with the Professional Issues Working Group;
- Facilitate closer links and cooperation with ENPHE. Collaborate with ENPHE on definitions and issues related to core competences and curriculum in physiotherapy in Europe;
- Gather information on whether education (at all levels and areas such as basic programmes, specialisation and from a Continuous Professional Development perspective) in physiotherapy is given according to Evidence Based Practice/Physiotherapy;
- Prepare the 2nd European Congress on Physiotherapy Education to take place in 2008.

Activities after June 2006

Overview of "projects" and distribution of responsibilities

The working group met for the first time, in this period, in Stockholm, Sweden, from the 14th to the 17th of September 2006.

The projects have been distributed to the members of the working group.

Considering that some of the projects are interlinked and need some coordination to avoid duplication of work, the various projects were grouped regarding their connections.

The Chairman of the WG has been charged to follow up the developments of the European Qualifications Framework for lifelong learning (EQF), recently established by the European Union.

- in Madrid, Spain, from the 18th to the 20th of January 2008
