There is one school of physiotherapy on the island, forming part of the University of Malta at Faculty of Health Science.

The school runs a 4 year degree course leading to Bachelor of Science (Honours) in Physiotherapy.

The Physiotherapy school is a member of ENPHE.

### **Status of profession:**

Professional Title/ Qualification:  
B.Sc. (Honours) Physiotherapy

Rules of professional conduct are presently determined by the state through the Council for the Professions Complimentary to Medicine (CPCM).

All physiotherapists must be state registered and obtain a licence to practice.

The practice of physiotherapy is professionally autonomous but not self-regulated.

### **Practice of physiotherapy:**

The major employer of Physiotherapists in Malta is the Department of Health, where physiotherapy is provided in the General State Hospital and Specialised State Hospitals for free and supported by National Insurance.

Physiotherapists also work in the private sector, in private hospitals and clinics around the island.
